"Prior to drafting any contract for goods or services, the responsible party or the decedent's survivor who is handling the funeral arrangements is entitled to receive a copy of any pre-need agreements in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent."

*REQUIRED PURCHASES - Charges are only for those items that you selected or that are required. If we are required by law or by a cemetery or crematory to use any items, we will explain the reasons in writing below.

We will accept all Life and Burial Insurance policies with a 4% + \$150.00 fee added on to the total purchase amount by our advance funeral funder. The original policy must be provided by the beneficiary and the policy must be assignable, incontestable and more than two years old. A fee of \$450.00 will be charged on any NSF checks returned from the bank.

Death Notification Checklist

When a family member or friend has died, it is important to notify various government agencies, banks, creditors and credit reporting agencies of the death. To reduce the risk of identity theft, these notifications should be made promptly after the death.

To expedite notification, you should initially make the contact by telephone followed by written verification. For many of the government agencies and financial entities, you will need the decedent's social security number, a copy of the death certificate, and if you are a personal representative, (executor) of the estate, your appointment form from the probate court. Make sure to retain copies of all notices that you send.

Below is a checklist of possible agencies and businesses that should be notified of the death. Because each individual case is unique, the list may not be complete. Also, the funeral home may have notified some of the government agencies on your behalf. Please consult with the funeral director when you receive this list so you can check off those agencies which have been notified by the funeral director.

FUNERAL ARRANGEMENT DISCLOSURE STATEMENT

The Federal Trade Commission Regulation Rule on "Funeral Industry Practices" requires certain disclosures and prohibits misrepresentations. The following is a checklist we ask you, the purchaser, to read and sign to verify that the funeral arrangement conference was conducted in compliance with the Federal Trade Commission regulation rule. The purchaser who made the funeral arrangements for the funeral and final disposition of the above-named decedent do hereby attest to the following:

- 1) Purchaser was given a copy of *The Consumer Guide To Funeral and Cemetery Purchases Booklet*.
- 2) Purchaser was given a General Price List, effective 08/16/2017 prior to discussing the funeral arrangements or the selection of any funeral goods and services.
- 3) Purchaser was given a Casket Price List effective 08/16/2017 prior to discussing caskets or the selection of a casket.
- 4) **"THERE IS NO EVIDENCE THAT ANY CASKET REPRESENTED AS HAVING PROTECTIVE FEATURES, WHICH MAY INCLUDE A GASKET, WILL PRESERVE HUMAN REMAINS."**
- 5) Purchaser was advised that the **state or federal law does not require embalming** except in certain special cases.
- 6) Purchaser was advised that all of our specially priced packages are for professional services only and do not include any merchandise such as caskets, urns, cremation containers, flowers, printed items or cash advance unless otherwise stated.
- 7) Purchaser was advised that state or local law requires an alternative container be used for cremations. San Diego Funeral Service uses a cardboard box for a alternative container. Purchaser may purchase a cardboard lined box, wooden box, wooden casket or use a rental casket, for the purpose of services chosen by the purchaser.
- 8) Purchaser was told the funeral firm costs on cash advance items may be different based on volume or cash discounts or other professional/trade customs where permitted by state local law.
- 9) San Diego Funeral Services does not sell outer burial containers.
